

Please note: deposit is fully refundable till October 1, 2026

Terms and Conditions

U.S. passport valid through July 2027 is required; anyone with non-U.S. passport, contact tour operator.

Payment schedule: \$500 per person deposit required to guarantee place on tour (couples can be \$1000 on one check). Second payment of \$1900 per person is due October 1. Final payment of \$2395 per person due November 15, 2026. Space is limited; enroll early to avoid disappointment--enrollment information below.

Tour price includes:

Air transportation for group flight can be on any scheduled airline (currently Delta). Cancellations after air tickets are issued are subject to a cancellation penalty as imposed by the airline. Current air fuel charge and taxes/fees are included. Please note: frequent flyer miles or credit card points cannot be used to purchase or upgrade air tickets; however, if you arrange your own airfare for whatever reason (fly earlier than group, different airline, using miles or points, upgrading to premium seats), deduct \$1598 per person at time of final payment.

Accommodations in deluxe hotels with private bath. Extra cost for anyone staying in a single room is \$1295.

Meals full daily buffet breakfasts and dinners in hotels.

Sightseeing as specified in the itinerary, including entrance fees and services of English-speaking guide.

All tips are included for guide, driver, hotels, restaurants, and porters.

Tour price based on minimum 43 total travelers and VAT and shekel/dollar exchange rate of March 1, 2026.

Luggage allowance is by airline policy for self-arranged flights.

Tour price does not include lunches; beverages not part of normal menus; sightseeing or services not specifically mentioned or noted as optional; baggage charges that may be implemented by airlines (none currently).

Cancellation policy: Deposits are fully refundable till October 1. Written cancellations received October 2-November 15, subject to a penalty of 50% of the total tour price. No refund for written cancellations received after November 15, 2026. No refund made for missed services while on tour. Deposits and payments are not transferable. *In addition to the above cancellation fees*, airline tickets are not refundable once issued. *We recommend the purchase of travel insurance*, which covers medical expenses while in Israel as well as emergency cancellation penalties, trip interruption expenses, and other areas of assistance; for travel insurance information contact our tour operator: ron.cansler@yahoo.com
